Honoraria

All league officers were in agreement that they did not feel there was a requirement to change the honoraria, this was presented by J. O'Donoghue and accepted by the league members.

- 8 Consideration of Proposals:
- **A)** Proposal from Steve James if a team wins a competition that has prize money and does not attend the presentation evening and collect it, they shall forfeit the prize money. **REJECTED**
- **B)** Proposal from Tony Hoskins (Strays) No food to be served at the end of the game or in between sets. **REJECTED**
- **C)** Proposal from John O'Donoghue (Klinkerbelles) Introduce a play off for Division 2 and Division 3 promotions, for teams finishing 3-6. **REJECTED**
- **D)** Proposal from Russ Loud (Rascals) to cap the number of registered players at 18 per team. **REJECTED**

- **E)** Proposal from Rich Salvage (White Hart Mavericks) to introduce a new cup to be awarded for the highest spare of the season over 18 (Must be 19 or greater) **CARRIED**
- **F)** Proposal from Simon Channing (Ginger Mingers) Introduce a new 100 ball competition. Details and full rules to be finalised by the League officers + committee. Competition to be non-compulsory and open registration from the teams of the league. **CARRIED**

G) Amend Rule 70c from:

"Highest Individual Away Average – Based on eight away League Matches (One trophy per division)."

to

Highest Individual Away Average – based on 50% of away league matches (One trophy per division). -- **CARRIED**

H) Amend rule 16b to change minimum sticker up fees from £22 to £24. - CARRIED

I) Amend rule 20 from:

"All scores must be completed in the score book and signed by both captains and a copy sent to the Results & Website Secretary by the home captain within 48 hours of the game commencing (Example – Wednesday 8pm, Thursday 8pm for a cup match) Failure to do so will result in a fine."

J) Remove rule 23b "The heel strip shall be 2" wide and 1" high." -- CARRIED

K) Amend rule 23c from:

"The distance between the heel strip and the white line shall be 14 feet"

to

The distance between the end of the alley and the white line shall be 14 feet"

L) Amend rule 23d from:

"No floor covering shall be allowed between the heel strip and the pit"

No Floor covering shall be allowed between the end of the alley and the pit.

M) Proposal from Matt Han (Beermasters) to amend rule 23n (Under standard of Alleys) from: "In the event of a written complaint, the Executive committee shall inspect the items listed and report the result to the next general committee meeting" to

The Executive Committee shall inspect all Alleys, Balls and Pins prior to the season starting" -- **REJECTED**

O) Introduce a new rule (23p) to read:

Subject to the review of Executive committee, if pins and balls are not up to league standard – a team may be subject to a fine, league points deduction or expulsion from the league"
